RESIDENTIAL SERVICES ARE MADE UP OF HOMES IN THE COMMUNITY WHERE ADULTS WITH INTELLECTUAL OR DEVELOPMENTAL DISABILITIES RESIDE. DIRECT SUPPORT PROFESSIONALS PROVIDE SUPPORT AND SUPERVISION TAILORED TO THE SPECIFIC NEEDS AND PREFERENCES OF THE INDIVIDUALS LIVING IN EACH RESIDENCE. IN MOST CASES, STAFF SUPPORT IS 24 HOURS A DAY, 7 DAYS A WEEK. SERVICES INCLUDE MEDICATION ADMINISTRATION, TRANSPORTATION, PERSONAL CARE, GOAL-SETTING, AND COMMUNITY. INVOLVEMENTS. INDIAN CREEK FOUNDATION BELIEVES THAT INDIVIDUALS WITH AN INTELLECTUAL OR DEVELOPMENTAL DISABILITY DESERVE TO LIVE IN A SAFE ENVIRONMENT THAT ENCOURAGES POSITIVE RELATIONSHIPS. INDIVIDUALS SERVED ARE SUPPORTED IN REALIZING THEIR LIFE GOALS THROUGH THE EXPRESSION OF PERSONAL CHOICE AND COMMUNITY. INVOLVEMENT.

WE ENGAGE OUR PARTICIPANTS IN ACTIVITIES DESIGNED TO HELP THEM EXPLORE POTENTIAL CAREERS, VOLUNTEERISM, AND OPPORTUNITIES FOR ONGOING ADULT LEARNING. THE LIFESHARING PROVIDER HELPS EACH INDIVIDUAL LEARN AND APPLY NEW SKILLS WHILE BECOMING A PART OF THE FAMILY’S EVERYDAY LIFE. THE LIFESHARING PROVIDER ALSO PROVIDES FOOD, SHELTER, AND CARE OF PERSONAL NEEDS. UNLICENSED RESIDENTIAL PROVIDES SUPPORT SERVICES TO ADULTS WITH A DEVELOPMENTAL DISABILITY LIVING ON THEIR OWN IN THE COMMUNITY. A VARIETY OF SUPPORTS ARE PROVIDED FOR EACH INDIVIDUAL BASED ON THEIR NEEDS. THESE SERVICES MAY INCLUDE ARRANGING MEDICAL APPOINTMENTS, ASSISTANCE WITH DAILY LIVING SKILLS, PROVIDING RECREATIONAL OPPORTUNITIES AND FINANCIAL MANAGEMENT. REVENUE RELATED TO THESE SERVICES WAS 980,663 AND EXPENSES WERE 727,894.
